 - i. Attorney Joe Infranco at ADF: attorney is not required
 - ii. <u>Harbor Compliance</u> to apply with 14 states (from which our largest donations have come), Harbor has quoted \$2100 plus \$449 in fees annually.
 - iii. <u>Charity Compliance Solutions</u> to comply in all 41 states that have compliance laws would charge \$150/state (same as Harbor) with a maximum of \$4995 annually
 - iv. AAPS does not comply
 - v. AAPLOG has not complied but is planning to do so moving forward. Donna recommended Atty Andrew Bath of Thomas More Society (abath@thomasmoresociety.org) He said they may be able to take care of this but Lisa is awaiting further details as of 3/20/17.
